3) The Director General of Police vide his letter read above has furnished detailed proposals in this regard for the consideration of the Working Group. The Working Group met on 15-05-2012 considered the proposals of the Director General of Police in detail and approved all the proposals except the mobility allowance component in the approved activities under mobility subhead in Community Policing Scheme as detailed below.

### I. Community Policing Scheme (₹200 lakhs)

The Scheme envisages to build-up a healthy relationship of Police with the Community, to work together in reducing crime. The details of approved components under the scheme for the year 2012-13 are furnished below.

**a. Community Policing News Letter**

Objective /Action is to give wide publicity to community policing initiatives so that the citizen can get first hand information of various services offered. The Nodal Officer of the programme will initiate necessary action for publishing the same.

**The beneficiaries are Public, Target Date- 30-09-2012**

**The amount proposed is ₹ 5.00 lakhs**

**b. Janamaithri Training.**

Objective /Action is to impart Janamaithri training having a duration of one day for officers (DySsP, CIs, SHOs) and 3 days for beat officers, assistant beat officers, community liaison officers and community relation officers of the existing 148 Community Police Stations and the proposed 100 Community Police Stations in Kerala Police Academy, Police Training College and in Police Headquarters. Food and remuneration to faculty members are to be provided by the department. Janamaithri training material has to be got printed and given to all participants.

In addition to the same, Janamaithri training has to be given to Janamaithri Samithi members in each of the 100 new Police Stations where the Project is being newly started. District level Seminar/Training has to be organized in all 19 Police Districts. For the purpose, ₹ 1 lakh each has to be given to 19 Police Districts.

**The beneficiaries are – Police personnel & Public.**

**Target Date- 30-09-2012**

**The amount proposed for this scheme is ₹ 30 Lakhs. (₹ 1 Lakh to PHQ, ₹ 4 Lakhs to KEPA, ₹ 6 Lakhs to PTC and ₹ 19 Lakhs to the districts @ ₹ 1 Lakh each)**

**c. Janamaithri Kendram Projects**

Objective /Action is to provide the basic infrastructure for the Community Policing programme. This Centre will be developed as Community Interaction Centre, which would facilitate Police – Public interface. Various Policing activities need cooperation and help from citizens.

An amount of ₹2 lakhs is to be allotted to the existing Janamaithri Kendrams for the following activities during the year 2012-2013.

1. Imparting palliative care/First Aid and Trauma Care training
2. Training programme to youth in sports, career counselling
3. Counselling to women and children, Domestic violence-awareness programme.

4. Training on Disaster Management
5. Awareness on Senior citizen care and providing facilities.
6. De addiction treatment/awareness.
7. Traffic awareness to children, youth and drivers

50% of the fund allotment is earmarked for the benefit of women, children and senior citizen. ₹2 Lakhs is to be allotted to the following 24 Janamaithri Kendrams for the above mentioned activities.

**d. Impact Study of the ongoing projects**

Objective /Action is to assess the impact of the Janamaithri Suraksha Project in 148 police stations of 19 Police Districts through Internationally/ Nationally acclaimed Institutes. The nodal officer of the programme will initiate necessary action for the same. The study should be totally independent and devoid of any departmental assistance.

**The beneficiaries are – General public and police**

**Target Date- December, 2012**

**The amount proposed is ₹10 Lakhs.**

**e. Campaign for creating Public Awareness**

Objective /Action is to create public awareness through wide spread publicity campaign by exploiting all the available means of communication such as print, electronic, internet media. The nodal officer of the programme will initiate necessary action for the same.

**The beneficiaries are – Police personnel and the public**

**Target Date – December, 2012**

**The amount proposed is ₹ 9 Lakhs**

**f. Incentives for public**

Objective /Action is to reward the public who impart exemplary contribution as part of promoting similar behaviour among the concerned which would result in tangible benefits of prevention of crime, reduction in fear of crime, reduction in traffic accidents, etc. An amount of ₹10,000/- each is to be given to the existing 148 Police stations and ₹ 5,200/- to the proposed 100 Janamaithri police stations. The scheme will be implemented through District Police Chiefs after identifying the deserving member from the public.

**The beneficiaries are – Public and police personnel**

**Target Date – October, 2012**

**The amount proposed is –₹ 20 lakhs (Through District Police Chiefs)**

**g. Mobility of Beat Officers and Asst. Beat Officers.**

Objective/Action is to ensure accessibility of beat officers in their respective beat area. By providing 45 each of scooters and motor cycles for use by beat officers and assistant beat officers, they would be able to respond the community needs quickly and effectively. It was also proposed to give a mobility allowance of ₹500/- so as to keep the beat officer, Assistant beat officers and community relations officers in constant touch with the public. This was very essential and strongly recommended by the Working Group and the file will be sent separately to Finance Department through circulation.

**Target Date – December 2012**

**The amount proposed is – 57 Lakhs (₹ 47 Lakhs to PHQ and ₹10 Lakhs to districts)**

#### **h. Community Policing in Coastal Areas**

Objective /Action is to strengthen Coastal Security which in turn is linked with National Security, by establishing Coastal Vigilance Committees throughout the 590 Km. long coast line. The scheme envisages strengthening of internal security activities through Community Policing activities in all 76 Coastal Police stations in Kerala. The objective is to counter terrorist and anti national activities which will enter our territory along the coast line, by fully utilizing the marine capability of our fishermen.

**The beneficiaries are – Coastal people,**

**Target Date – January 2013**

**The amount proposed is – ₹19 lakhs (₹25,000/-per Kadalora Jagratha Samithi)**

### **II. Student Police Cadet Scheme (₹ 220 Lakhs)**

#### **a. Uniform for Cadets/CPO/ACPO & Refreshment Cost**

The Scheme envisaged to distribute ₹1 lakh each to 100 schools where the scheme is ongoing and the 100 newly proposed schools. Out of this ₹ 53,000/- is earmarked for the procurement of uniform for cadets, ₹1,500/- for CPOs/ACPOs. Remaining amount of ₹45,500/- is earmarked for refreshment costs for the cadets during sessions.

**The amount proposed is 200 Lakhs ( ₹1 Lakh per school through DPCs)**

#### **b. State Level Summer Camps & Camp Day Allowances**

Objective /Action is to promote importance of group endeavour and also inculcating discipline and civic sense among student police cadets. It is proposed to conduct State Level Summer Camps/District level summer camps for participants selected state wide. The nodal officer of the programme will initiate necessary action for the same.

**The amount proposed is – ₹20 lakhs**

### **III. Internal Administrative Processing System -IAPS (₹225 lakhs)**

Objective /Action is to link the Administrative Wings of the Police Department of various Districts to create an Administrative Office Connectivity throughout the State and to digitalize all the administrative works.

The scheme mainly involves the development of software modules and procurement of Servers (Data base, SAN & Processing) , Desktop Computers, Multi Document Scanner, Multi Function Printer, On line UPS, Electrification and Networking, Maintenance and Support ) as detailed below.

Printing, copying, binding and other related works have to be undertaken on short notice. Reports have to be filed before NHRC, SHRC, and Honourable Courts etc on short notice on mishaps accidents and sensitive issues. Documents have to be prepared during General Elections also.

. The scheme involves purchase of photocopiers, Printers, Risographs, LCD Projectors, Multi Colour Duplicators, Laminating machines and Binding Machines etc at a total cost of ₹137 Lakhs as detailed below.

#### **a. Digitizing Investigation Process**

Objective /Action is to digitise evidences in the form of call details, e-mails, digital photographs, ATM transaction, digital video or audio files as the same is admissible in the Court as per the latest amendments in Criminal Procedure Code and Indian Evidence Act.

#### **b. Electronic Beat System**

Objective /Action is to monitor the movement of the policemen in their jurisdiction as part of performing beat duties by electronic means. It helps to create digitized map of the pattern of movement and time taken for more effective policing. The programme involves procurement of electronic devices.

## **VI.Streamlining Police Response Facilitating Intelligence Driven Policing** **(₹40 lakhs)**

### **VIII. ICT Enabled Citizen Helpdesks in Police Stations (₹ 24 Lakhs)**

Objective /Action is to provide basic information and other services to the citizens who approach the Police Stations through “Reception-cum-Helpdesks”. The department has also adopted e-mail as basic medium of communication and to enable this facility, broadband connectivity of the police Stations is being taken up by the IT Department. To effectively tackle the issues of details of missing persons and to provide a prompt and comprehensive response, there is the need to set up a “Bureau for Missing Women and Children” which maintains a database of all the missing persons and this bureau can interact with other States in the country to expedite flow of information and to facilitate investigative process outside the home state. This interface will enable a single-window response to the citizen who approach the Police Station and will result in saving of time and effort for both citizens and the department.

After the introduction of 2G and 3G and availability of high-end mobile-phones and other gadgets, communication sector is expanding. So it is necessary to implement Tetra or Digital Mobile Radio System for Police Communication.

Setting up of Women Helpdesks, Vanitha Vigyana Vyapana Kendrams in Police Stations making Janamaithri Police Stations into women friendly Police Stations and Victim Support Scheme etc are the major activities under taken in this scheme.

An amount of ₹480 lakhs has been allotted for the implementation of various activities under Flagship Programme on Gender Awareness as follows

**a. Strengthening School Protection Groups (₹ 22 lakhs)**

Objective /Action is to react against delinquencies among school children such as abuse of drugs, alcoholism, misuse of mobile phones etc as well as in giving counselling to teenage girls through School Protection Groups. PTA, Students, Community members and Police are members of the SPG. The scheme will be implemented through District Police Chiefs.

The beneficiaries are – Girls students of Schools and Colleges,  
Target Date- February , 2013

The amount proposed is –₹22 lakhs (₹ 5,000 X440 through District Police Chiefs)

**b. Victim Support Scheme for the entire State (₹ 43 lakhs)**

Objective /Action is to assist women victims, such as victims of violent crimes like rape, domestic violence etc. A woman victim of violent crime can first contact the police officials of their respective areas. From there they have to be immediately transported to the hospital. A comfortable place for counselling, arranging for a short stay home, and providing the service of a lady Advocate etc. are required. The payment for transport of the victims to hospitals, to the counsellors, Lady Advocate and for the short stay facilities may be limited to ₹2,000/- in each case, for which, an imprest money of ₹ 22,000/- each may be provided with each Circle Inspectors.

The beneficiaries are – Women Victims

Target Date- February , 2013

The amount proposed is ₹43 Lakhs.(192 CIs X ₹ 22,000 + ₹76,000 to SP, Women Cell)

**c. Research Study on Women Victims (₹10 lakhs)**

Objective /Action is to conduct a research study on women victims of crimes as well as conviction rate/ reasons for acquittal and how to strengthen criminal investigation and prosecution and how it will help the Department to formulate various projects for the welfare of women victims. The nodal officer of the programme will initiate necessary action for the same.

The beneficiaries are- Women & Girls

Target Date- February, 2013

The amount proposed is – ₹10 lakhs (Police Headquarters)

c. **Improvement of Women Helpdesks in Police Stations (₹ 110 lakhs)**

Objective /Action is to provide congenial facilities to the women petitioners/victims who approach Police Stations for help. The sanctioned amount of ₹110 lakhs is to be utilized for improving the facilities of the existing helpdesks and extending the programme to more police stations.

**The beneficiaries are – Women victims & Petitioners**

**Target Date- February 2013.**

**The amount proposed is – ₹110 lakhs**

d. **District Level Seminars (₹ 38 lakhs)**

Objective /Action is to organise Seminars/ Training on Gender specific issues in all Police Districts for creating awareness on crime against women and children and also to fight against child abuse, domestic violence, child employment etc. The major challenge which the Society and Police are now facing is in the realm of Cyber crimes. Crimes like Pornography, Cyber Stalking, Cyber Cheating, Hacking etc are primarily used against women and it is found that increasing women are becoming victims in various cyber crimes. Most of this happen due to lack of awareness and poor cyber security measures adopted. Hence as a first step to reduce these crimes, it is essential that the Department put up a detailed programme to spread awareness among women on precautions to be taken in the Cyber World. In this regard the Department are planning to hold an International Cyber Security Seminar, aimed at providing a platform to discuss, showcase, educate, understand and spread awareness on the latest trends in cyber and hi-tech crimes, with particular reference to women.

It also aims to provide a hand-shaking platform for various Government organizations including the various investigation agencies, academia, research organizations and other industry leaders and players for better co-ordination in making the cyber world a better and safe place to be. It will also serve as a platform to devise strategies to prevent Cyber crimes against women.

The conference will be held in Thiruvananthapuram during August 2012. Out of the ₹38 Lakhs provided , ₹10 lakhs will be allotted to Thiruvananthapuram City/ Rural, ₹1.80 Lakh each to Kollam, Kochi, Thrissur and Kozhikode Cities and ₹ 1.60 Lakh each to other 13 Police Districts.

**The amount proposed is –₹38 lakhs (₹10 lakhs to Tvpm City & Rural, ₹1.80 lakhs each to other three cities, and ₹1.60 lakhs each to rest Districts)**

e. **Special Policing Initiatives for Prevention, Detection and Speedy Disposal of Crime Against Woman (₹ 157 lakhs)**

Objective /Action is to strengthen policing initiatives on crimes against woman like rape, molestation and eve-teasing. The victims are usually students and women workers. The scheme involves

- Covert and overt surveillance at vulnerable areas like bus-stops, railway-stations, junctions, cinema theatres, in front of Colleges, Parallel colleges etc and during festivities where a large number of people gather.
- Fast investigation of petitions of women victims by Cyber Police Stations and Hi-tech cells by giving special priority for which cyber crime investigation and detection – equipments have to be purchased.
- Sensitization of girls and women about the dangers related to mobile phones and internet and also to teach them about their rights/ privileges.
- Frequent checks and covert counter operations by WPCs using cameras.

Objective /Action is to improve the women friendliness of police stations by providing tables, chairs and modular cabin each in women rest rooms attached to the Police Stations.

The amount proposed is –₹100 lakhs (Police Headquarters)

5) The Director General of Police will furnish quarterly progress report on the scheme wise progress, achieved in the implementation of the above schemes.


